



## LEVEL OF IMPORTANCE

This building is linked visually with the Wombat Hill gardens and is visible from most of the township area. As such its identity is strongly linked with that of Daylesford itself. It is also important for its role played in the social history of the community, for its associations with the gold mining industry and for its arresting and varied architectural form.







## HISTORICAL DESCRIPTION

Richard Brett purchased this lot at the 1854 land sale (H.T., Maddicks) and "Uncle Nod's Bowling Alley" had been erected there by 1865 (H.T. Maddicks). By 1870, William Tarleton owned a shop in this vicinity, land further to the east being vacant at that time. Lot 10 was possibly vacant in 1902 (Directories) but was occupied jointly by Miss F. Allan, a dressmaker, and Edward Cooper, dealer, by 1909 (Sands and McDougall Directory).

# ARCHITECTURAL DESCRIPTION

An Edwardian pair of detached houses, unique in Daylesford, and being double fronted. Each dwelling is finished in rough cast, the gable ends are "half timbered" and the principal casement windows segmentally arched. The ridge lines are terminated with metal finials.

## ,0, LEVEL OF IMPORTANCE

Together, Nos. 14 and 16 Albert Street are a unique pair, in Daylesford, and form part of the Albert Street precinct.



### HISTORICAL DESCRIPTION

W. King, councillor and businessman, acquired this allotment from the Crown during the early land sales of the mid 1850's. The Commercial Hotel (q.v.) occupies most of King's original purchase, and this house adjoins it on its eastern property boundary.

### ARCHITECTURAL DESCRIPTION

A two storey timber residence, unique in Daylesford, with two level timber verandah overlooking Albert Street. Remnant cast iron lace work displays a cockatoo motif. The roof is hipped and the street elevation symmetrical with central, panelled doors at both levels, flanked by windows.

### LEVEL OF IMPORTANCE 'C'

A key building in the Albert Street precinct, situated at the west end of a row of single storey timber cottages extending as far east as the bowling club on the Camp Street corner. A unique house form in Daylesford.



### HISTORICAL DESCRIPTION

Richard R. Brett acquired lot 8 and adjoining lot 10 at the first land sale of October 1854. By the early 1860's, G.W. Parker, wheelwright and blacksmith, had established his business here, which continued under his name into the early years of this century (Sands & McDougall Directory, 1902). By 1909, it had passed to Joseph Kinsman who also had a coach builders at the rear.

It was occupied by the Daylesford Tyre Service in 1981 and remains unchanged today.

### ARCHITECTURAL DESCRIPTION

A brick building with timber trusses forming a corrugated iron gabled roof, and having a parapeted brick facade to Albert Street. This facade is trabeated, with a decorated brick cornice employing angled brickwork, popular in Daylesford at this time. The arched carriageway door is flanked by windows in a symmetrical composition.

### LEVEL OF IMPORTANCE 'D'

This building is of interest in that it is one of relatively few early industrial buildings surviving in the township.

### HISTORICAL DESCRIPTION

Lars Nicolai Gui acquired lots 1, 2 and 3 forming the southern portion of section 5, facing Albert Street, during the early land sales of the 1850's. By the early 1860's A. Birrel ran his grocery store on this corner site and on 22/4/1871, W. Barkley was advertising in the "Daylesford Mercury and Express" that he was reopening his grocery and provision store here in the shop lately occupied by J.P. Green, whose bakery and confectionery business would be conducted "as heretofore". Later on, the corner buildings were to be known as Evans Big Store (H.T. Maddicks).

### ARCHITECTURAL DESCRIPTION

A large, by Daylesford's standards, single storey hip roofed brick store with timber framed shop windows to the Albert and Vincent Street frontages. The corner is splayed and contains the entrance doors. Externally, the store is characterised by a timber posted verandah and corrugated iron lined parapet to both street elevations, whilst internally it retains its timber ceiling linings.

### LEVEL OF IMPORTANCE 'D'

A key building in the Vincent Street Commercial precinct.

### HISTORICAL DESCRIPTION

Lars Gui acquired Lot 5 from the Crown during the early land sales of the mid 1850's.

By the turn of the century (Daylesford Historical Society and Sands & McDougall Directory, 1902) this building was occupied by A.R. Anson, butcher.

### ARCHITECTURAL DESCRIPTION

A two storeyed residence with shop and splayed ingo occupying half of the ground floor frontage and lean-to section at rear. The main facade is cement rendered with cornice moulds generally similar to existing shops dating from the 1860's in Vincent Street. The timber posted verandah is not original and the original residential entrance is intact.

### LEVEL OF IMPORTANCE 'D'


This building's importance is derived from its place amongst Daylesford's earliest permanent commercial buildings. Its location in Albert Street, slightly out of the mainstream of present day commercial activity, is also of interest and assists one to understand the extent of the Vincent Street centre in the 1860's.

### HISTORICAL DESCRIPTION

Lars Nicolas Gui purchased lots 1, 2 and 3, forming the southern portion of section 5, facing Albert Street, during the early land sales of the 1850's.

The Salvation Army held its first meeting in the Albert Hall in 1883 under the direction of Major Rolfe. The memorial block for the citadel was laid in April 1887, and it was occupied by core no. 104, having a capacity of 350. Lieutenant Colonel Elizabeth Spargo commenced here as an officer before becoming the first matron of Bethesda hospital and the first appointee to the Army's district nursing activities, in 1903. She is noted also for her pioneering work in the field of female drug and alcohol abuse. The Army's brass band had 10 players under bandmaster Sampson and is known to have played in the former Wombat Hill rotunda. The last officer appointed in Daylesford was Senior Captain Dorothy Turner, 22nd August, 1965. The citadel closed in 1968.

### ARCHITECTURAL DESCRIPTION

A timber hall, originally with a castellated parapet and projecting porch extending to the roofline in the form of a tower surmounted by a flagpole. Its architectural style was sympathetic with the notion of a citadel in the tradition of other Army buildings of the day. The front doors with semi-circular fanlight over are flanked by windows and former ventilators, whilst the entire facade and return for approximately 3 metres is lined with ashlar boarding.

In recent years, the parapet and tower has been removed and replaced with barges and king post decoration to the formerly concealed gable end.

### LEVEL OF IMPORTANCE 'C'

Although substantially altered, the former Salvation Army citadel is of interest for its role in the communities of Daylesford and Hepburn Springs over the years. Its association with Elizabeth Spargo is of note, whilst the design of the building, though significantly altered, is comparable with that of other Army citadels.





### HISTORICAL DESCRIPTION

Julius Brabant purchased lots 1-3 from the Crown on 14-7-1859.

In 1926 (Rate Book), No. 39 was owned either by Margaret Hope, or Peter Kronan.

### ARCHITECTURAL DESCRIPTION

A single fronted parapetted house, erected on the street alignment. The masonry walls are rendered and the parapet trimmed with a cornice mould. The windows have plain cement render surrounds with chamfered reveals. The attached residence to the east is possibly of more recent date and is of timber construction.



Good. The front flyscreen door is unsympathetic, whilst a garage and additions have been added on the west elevation. The important features of the street elevation, which include the window dressings, are in tact. The paintwork is probably recent.

### HISTORICAL DESCRIPTION

Adam purchased his allotment during the middle 1850's and the house was built there during the 1860's. It may have been built by J. Lavezzolo, who erected the Albert Hotel and owned the adjoining residence (Rate Book 1870). In 1870 it was occupied by a Mr. James Edward Geake. By 1926, it had passed to the Wombat Boot Factory and was in use as the manager's residence (Rate Book 1926). In , it was purchased by the Daytex Textile Mills.

### ARCHITECTURAL DESCRIPTION

A simple cottage design of the Colonial era, its principal facade is embellished with cement rendered window dressings and decorated plates to the tension rod ends. Its corrugated iron hip roof places it amongst a relatively small group of similar cottages in Daylesford, whilst the window dressings, unique in the town, are common elsewhere. The similarity between this building and a large number of cottages in Warrnambool is of interest.

### LEVEL OF IMPORTANCE 'C'

The importance of this house derives principally from its close visual association with the Albert Hotel and the Court House group. It is situated within the Albert Street precinct and is an unusual house in its local context.



Fair. There is evidence of structural movement on the principal facades.

Good. The building is substantially in tact, and includes a wrought iron lamp bracket over the former hotel entrance, and a cast iron palisade fence along the north elevation.

### HISTORICAL DESCRIPTION

Lot 10 was granted to S. Adam during the middle 1850's and the present hotel built there during the early 1860's for Mr. J. Law zzolo, who was also proprietor of the Victoria Hotel, in Vincent Street (Daylesford Mercury 1-7-1864). Law zzolo objected to the road levels constructed around his building in 1864 (Daylesford Mercury 1-7-1864) which resulted in the basement like aspect of his rooms, on its north elevation. Evidently, they were leased as offices, for it was George Thomson, a solicitor, who "removed to the basement storey of the Albert Hotel" in 1871 (Daylesford Mercury 3-1-1871).

Later Frederick Wissing was the licensee and it was during his term of office that a theatre was added immediately to the south (Daylesford Advocate 30-12-1930). The additions were hip roofed structures with round arched windows repeating the theme established by the corner hotel (Rider & Mercer Litho: Historical Society).

Johan Dolphin was the licensee in 1895-96 (Wilton's Directory) and in 1902 it was Joseph Nelson (Sands and McDougall Directory). By 1909 it was known as the "Court House" Hotel, under the proprietorship of A.G. Burgess. By 1920 it had been delicensed (Sands and McDougall Directory: no entry).

Following closure, the complex of buildings, which includes the residence immediately to the west, was purchased for use by the Wombat Boot Factory (refer No. Albert Street), (Rate Book 1926), whilst an existing sign by the former hotel entrance reads "Geo. Ananson, Late 1st and 2nd A.I.F., Boot and Shoe Repairer". It may have been during this period that the important elements of the theatre were demolished.

In , the complex was purchased by the Daytex Textile Mills, which vacated these premises in c.1979. They are now vacant.

### ARCHITECTURAL DESCRIPTION

The remaining portion of the hotel complex (refer. No. Albert Street for details of the residence) has a cement rendered parapetted facade, with a corner splay and entrance, in the manner of many Victorian hotels. Its classical proportions and detail include the cornice, quoining, Palladian windows to both elevations and the rounded arches to all upper level openings. The iron work, noted elsewhere, is important. Remnant signage includes the former hotel name, to both elevations along the frieze panel, immediately under the cornice line. The letter face is Tuscan. The name "Harper" is discernible over the main entrance.

The former hotel is a key building within the Albert Street precinct, and is visually linked with the Court House group. It is the oldest hotel in Daylesford to retain its original facade, and is important in the streetscape as a particularly "urban" element, built to the street alignment, and retaining its original ironwork.

## HISTORICAL DESCRIPTION

Mr. G.H. Jamison purchased the land on which the former hotel now stands at the early Government land sales and built the section of the building facing Raglan Street in 1859. He was the first postmaster in Daylesford and a gentleman of standing in the community, Jamison Street (which runs into Wills Square from the north) being named after him. In 1864 (Daylesford Mercury 1-7-1864) a letterbox was "to be established for the benefit of the inhabitants of the north-east portion of the township" at Jamison's Hotel, the post office at that time being situated on the corner of Stanbridge and Vincent Streets, and Jamison no doubt used his influence to hasten its construction. It was in use there by 1865. At this time, and for many years afterwards, Cobb & Co's office and Royal Mail receiving point - another link with Jamison's position as postmaster - was located within his hotel, coaches setting out regularly from this point to Castlemaine, Melbourne (Australian Stage Company: G.H. Jamison, Agent) and Ballarat (Daylesford Mercury 2-2-1864).

Later the second portion of the hotel, which now faces the square, was added and during the 1890's the present cast iron verandah was erected. In 1871, the Daylesford Mercury noted that G.H. Jamison "has removed to Freemasons Hotel, Melbourne", subsequent proprietors including Agnes Skardon. # ARCHITECTURAL DESCRIPTION

The hotel is a substantial two-storey building commanding a key position at Wills Square. It presents a pilastered facade to the street, simply detailed, with a corrugated iron roof concealed by a parapet. The two-storey verandah includes cast iron columns, and lacework, and is the largest in the town. Also of importance are the basalt lined open drains at the base of the verandah, the brick lined open drains within the proper the ostler's quarters and former stables, and letter receiving box. # LEVEL OF IMPORTANCE '

The former hotel is a key building in the Wills Square precinct, which is critically situated at the entrance to town, along Raglan Street, and formerly along Jamison Street from Hepburn Springs. It was at one time one of Daylesford's principal hotels and is also important for its

associations with Jamison, the post office, and Cobb and Co. Wills Square is an important pivotal point in the town, and the former hotel dramatically marks the entry to the Churches & Albert Street precincts, the Commercial precinct and to the Raglan Street precinct.



# ARCHITECTURAL DESCRIPTION

The Daylesford Court House is typical of the Public Works Department's designs of the period, and consists of a dominating gable over the main court room, with flanking offices, vestibule and verandah. Simple decorations are also typical, and include brick corbels in the Lombardic tradition to the gable ends, round arched windows and attached brick piers, with a simulated portico adding emphasis to the main entrance.

## LEVEL OF IMPORTANCE , C ,

The Court House is an in tact example of a PWD design of the period and is sited imposingly on the axis of Albert Street, on rising ground overlooking the township. It is a key building in the Church precinct, and its contribution to the precinct is strengthened by its association with other buildings including the lock-up, residence and former receipt and pay office.



It is a cement rendered brick structure with a single projecting wing and is substantially in tact. Similar police quarters buildings exist at Mandurang, Donnybrook, Rosedale, Marong, Kerang, Horsham, Koroit and Kingston.

### LEVEL OF IMPORTANCE 'C'

The former police residence is an unusual example of PWD domestic architecture of its period and is similar to the police residence in Heidelberg. It is situated on the slopes of Wombat Hill, overlooking the Daylesford township. It is a key building in the Court House group and a unique house design in Daylesford.



### HISTORICAL DESCRIPTION

The Rev. William Jarrett commenced services in Daylesford in 1862, a wooden building capable of accommodating 300 persons being opened on 31st May, 1863. The church was located a fair distance from the Camp Street frontage owing to the existence of the mining operations of the Township Lead in this vicinity.

In 1904, it was replaced by the present church and has been in use since as a hall and Sunday School.

### ARCHITECTURAL DESCRIPTION

A simple timber building with steeply sloping corrugated iron roof concealing the original timber shingles. The belfry, surmounted by a guilded vane has been removed.

Inside, the walls have a timber dado and the ceiling is timber lined. The electric light fittings are early, and of note. The windows have stained glasswork, whilst an illustrated verse painted in 1893 over the place for the table reads: "Come unto me all ye that labour and are heavy laden, and I will give you rest." Beneath the timber floor is a rammed earth floor (not inspected).

### LEVEL OF IMPORTANCE 'B'

An early public building in Daylesford, of importance to the history of the Presbyterian Church in the parish. It is the only timber church building in the Churches Precinct and is an essential component of the Presbyterian Church complex.

## HISTORICAL DESCRIPTION

The western wing was built in 1857 to serve as the denominational school, and was used for services prior to the construction of the adjoining church. The girls room at the eastern end was added in 1864 and paid for by W.E. Stanbridge, of Wombat Park, whose practice it was to obtain royalty payments for gold extracted from mines on his estate. In this case, the inscription on the building shows that the funds were obtained from the "Concordia tunnel and the Defiance paddock".



Opened on 4-5-1857 with 50 pupils, it was closed on 31-12-1873, with its principal, Robert Knox, transferring to the new State School, No. SS1350. In 1867, part of the older section was destroyed in a hurricane. During the 1880's it was used as a college, and today it is used as the church hall.

### ARCHITECTURAL DESCRIPTION

An austerely treated, cement rendered ecclesiastrial building, with buttressed walls, lancet windows and drip moulds to some openings. The bare walls are sandstone and the roof linings formerly shingles. The cement rendered surfaces have ashlar markings.

### LEVEL OF IMPORTANCE 'C'

The former denominational school is a good example of one of the denominational board's schools and a key building of the Anglican Church group. ## HISTORICAL DESCRIPTION

Daylesford's first Church of England clergyman was the Rev. R.J. Cheyne, overseeing the Loddon district, and commencing work in 1857. In November, 1860, the Rev. E.C. Bryce became the first parish incumbent. Services were held initially in the adjoining school room of 1857, and the foundation stone was laid on 12th December, 1862. The architect, Leonard Terry, had his work supervised by F. Paeple, Architect.

The church was opened on 6th December, 1863. Subsequently, in 1867 and 1870, the roof was damaged by a storm. In 1871 a gallery was added and the present Fincham pipe organ installed. Consecration occurred in 1894 and in 1896 W.E. Stanbridge bequeathed the sum of £1,000 for the erection of the present brick chancel, sanctuary an belfry. In 1940, Mrs. Parker donated the rood screen, and in 1963 the sanctuary windows were donated in memory of members of the Cox family, thereby continuing the association of "Wombat Park" with this church.

# ARCHITECTURAL DESCRIPTION

A sandstone church in the Early English Gothic style, with porch and brick additions consisting of chancel, sanctuary, belfry and minor rooms. The tower originally envisaged at the north-west corner was never built and the present entrance porch was provided instead.
