5.1. PROPOSED COUNCIL PLAN 2017-2021, STRATEGIC RESOURCE PLAN 2017-2021, PROPOSED BUDGET 2017/2018 AND ROAD MANAGEMENT PLAN (VERSION 5) – HEARING OF SUBMISSIONS

GENERAL MANAGER CORPORATE SERVICES

In providing this advice to Council as the Manager Finance and Information Technology, I Trafford Thompson have no interests to disclose in this report.

PURPOSE

The purpose of this report is for Council to provide an opportunity for submitters to speak to their submissions in response to the Proposed Council Plan 2017-2021, Strategic Resource Plan 2017-2021, Budget 2017-2018, or Road Management Plan (Version 5) at a formal meeting of Council.

BACKGROUND

The Proposed Council Plan 2017-2021, Proposed Strategic Resource Plan 2017-2021, Proposed Budget 2017-2018 and Road Management Plan (Version5) have been on public exhibition in accordance with Section 223 of the *Local Government Act 1989* for the period 26 April 2017 to 24 May 2017.

ISSUE / DISCUSSION

Submissions closed at 5pm on Wednesday 24 May 2017 for each document on display, except for the Road Management Plan which closed on 1 June 2017 due to the need for public notification in the Government Gazette.

Six submissions were received during the Section 223 public exhibition period. In addition, one budget submission was received prior to the commencement of the public exhibition period relating to an item not in the budget, which we have included for completeness. Details provided by submitters have been made available to Councillors for the June Council Briefing. A summary of submissions received is provided below.

Any person could make a submission to the Council on any proposal contained in the documents or to submit a new proposal. Submissions received by the Council before 5pm on Wednesday 24 May 2017 (RMP, 1June 2017) will be considered by Council.

All submitters who did not express that they wanted to address Council, were contacted to confirm if they wanted to be heard in favour of their submission at this Special Council Meeting.

As part of Council's budget and Council Plan consultation process, Council held five information sessions in Trentham, Creswick, Glenlyon, Clunes and Daylesford during May. The public notice and additional information was included in *The Advocate* on Wednesday 26 April 2017.

At the Council Meeting scheduled for 6pm on Tuesday 20 June 2017 to be held in the Daylesford Senior Citizens' Room, Council will formally meet to consider and adopt the Proposed Council Plan 2017-2021, Strategic Resource Plan 2017-2021, Budget 2017-2018 and Road Management Plan (Version 5).
