5. OFFICER'S REPORTS

5.1. PROPOSED BUDGET 2018-2019 – HEARING OF SUBMISSIONS GENERAL MANAGER COMMUNITY & CORPORATE SERVICES

In providing this advice to Council as the Manager Finance and Information Technology, I Trafford Thompson have no interests to disclose in this report.

PURPOSE

The purpose of this report is for Council to provide an opportunity for submitters to speak to their submissions in response to the Proposed Budget 2018-2019 at a formal meeting of Council.

BACKGROUND

The Proposed Budget 2018-2019 has been on public exhibition in accordance with Section 223 of the *Local Government Act 1989* for the period 25 April 2018 to 25 May 2018.

ISSUE / DISCUSSION

Submissions closed at 5pm on Friday 25 May 2018. Five submissions were received during the Section 223 public exhibition period. Details provided by submitters have been made available to Councillors for the June Council Briefing. A summary of submissions received is provided below.

Glenda Fleischer, Secretary Glenlyon Progress Association	Full support for the \$70,000 for Glenlyon allocated in the proposed Budget
Kenneth Kronberger	Creswick projects, incl. fountain restoration, signage for Creswick creek, Calembeen Park and St Georges Lake, South Street Spring
Zachary Casper	Numerous items addressed including project allocations, content within section 2 of the budget document and borrowings vs budgeted surplus
Graeme Orr and Heather Mutimer	Wills Square Fountain maintenance
Brenda Blackmore and Chris Clare	Proposal to reallocate and repurpose the Glenlyon Market Shelter allocation to a similar project within Glenlyon Recreation Reserve

All submitters who did not express that they wanted to address Council, were contacted to confirm if they wanted to be heard in favour of their submission at this Special Council Meeting.

As part of Council's budget consultation process, Council held five information sessions in Trentham, Creswick, Glenlyon, Clunes and Daylesford during May. The



public notice and additional information was included in *The Advocate* on Wednesday 25 April 2018.

At the Council Meeting scheduled for 6pm on Tuesday 19 June 2018 to be held in The Warehouse, Clunes, Council will formally meet to consider and adopt the Budget 2018-2019.

Council has provided the opportunity for those submitters who have previously indicated to Council they wish to be heard, to speak to their submissions.
