### IMPORTANT INFORMATION

State Government levy: The State Government levy of \$4.23 per dog registration and \$4.23 per cat registration is primarily used to fund responsible pet ownership education programs. The levy is included in the registration fee.

If you wish to claim a REDUCED FEE, the following rules apply:

- Desexed/Over 10 years if not previously supplied, a vet certificate or statement OR completion of the statutory declaration below for each animal.
- Working Dog the property address must be rated as a FARM and the dog must be an appropriate breed.
- Breeding/Trained/Association if not previously supplied, satisfactory documentary evidence to support claim.

Your responsibilities as a pet owner:

- All dogs and cats over the age of 12 weeks must be registered
- Please contain your cat to your property
- Council has enacted a Cat Curfew which started 1 July 2023. More information at hepburn.vic.gov.au/Residents/Animals/Cat-curfew

- Ensure all dogs are under effective control when out in public
- Dogs must be securely confined to your property at other times
